### WINCHESTER CITY COUNCIL ROAD TRAFFIC REGULATION ACT 1984

# THE HAMPSHIRE (VARIOUS ROADS, WHITELEY) (PARKING PLACES AND RESTRICTION OF WAITING) ORDER 2004 (VARIATION NO.4) ORDER 2020

Winchester City Council acting on behalf of Hampshire County Council in exercise of its powers and duties under Sections 1, 2, 4, 122 (1) and (2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act"), as amended by the Road Traffic Regulation (Parking) Act 1986 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following order:-

- In this order "the Act" means the Road Traffic Regulation Act 1984; and the "Principal Order" means "The Hampshire (Various Roads, Whiteley) (Parking Places and Restriction of Waiting) Order 2004" as amended.
- 2. The Principal Order shall have effect in that the items specified in Schedule I of this Order shall be deleted from Schedule II (No Waiting At Any Time), and the items specified in Schedule II of this Order shall be deleted from Schedule IV (No Waiting Monday to Friday 8am to 6pm).
- 3. The Principal Order shall have effect as though the items specified in Schedule III of this Order shall be inserted in Schedule II (No Waiting at Any Time), and the items specified in Schedule IV of this Order shall be inserted in Schedule IV (No Waiting Monday to Friday 8am to 6pm).
- 4. The Principal Order shall have effect as to revoke Articles 18 and 19 and replace with the following:
  - "18. Save as provided in Articles 20, 21, 22 and 23 of this Order, no person shall, except upon the direction or with the permission of a police constable in uniform or parking attendant, cause or permit any vehicle to wait:-

- (i) At any time on any sides of road specified in Schedule II or Schedule III to this Order.
- (ii) Between the hours of 8am and 6pm on a Monday, Tuesday, Wednesday, Thursday or Friday on the sides of road specified in Schedule IV to this Order."
- 5. The Principal Order shall have effect as to revoke Article 21 and replace with the following:
  - "21. Nothing in Article 18 of this Order shall render it unlawful to cause or permit any vehicle to wait on any of the sides of roads specified in Schedules II and IV of this Order for so long as may be necessary to enable goods to be loaded onto or unloaded from the vehicle."
- 6. The Principal Order shall have effect as to revoke Article 22 and replace with the following:
  - "22. Nothing in Article 18 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a valid disabled person's badge and a parking disc (on which the driver or other person in charge of the vehicle has marked with the time at which the period of waiting began) to wait on any of the sides of road specified in Schedules II and IV for a period not exceeding three hours (and not being a period separated by an interval of less than one hour from the previous period of waiting by the same vehicle on the same side of road on the same day)."
- This Order shall come into operation on 17<sup>th</sup> February 2021 and may be cited as
  The Hampshire (Various Roads, Whiteley) (Parking Places and Restriction of Waiting)
  Order 2004 (Variation No. 4) Order 2020
