Your request is not a formal freedom of information request however I can provide the following information which may be of help to you.

I have located the file I think you have referred to. Its reference is 10/00112/MIXED. Mr Riding was advised by yourself that the caravan was used as overflow accommodation from the main dwelling and at

the time [REDACTED] daughter and son in law lived in the caravan and it was deemed ancillary to the dwellinghouse. It was made clear that should the caravan be occupied separately it would form a separate planning unit requiring planning permission.

Another file which may be of interest is 16/00294/CARAVN referring to a different caravan on [REDACTED] land. Following correspondence with [REDACTED] the caravan was removed and photos dated 8 December 2016 show no caravan (touring or static) present on the land. The case was closed.

The allegation I am investigating is in respect of a different mobile home and a touring caravan located on [REDACTED] land.

Unfortunately I do not have my records on this matter - I am now retired and have disposed of all my old files.


