Proposal: We wish to remove 2 branches from the 20m tall/60cm diameter Conifer tree, that is just beyond their garden's far south-western corner. One is about 3.3m up, & 12.5cm in diameter, on its north-western side, with the other being 7.5m up, & 10cm in diameter/6m long; 2 - the smallest of the 3 Conifers, is the middle one, being about 12m tall, & 20cm in diameter, just to tree 1's eastern side. We'd like to hedge-trim it, thus tip-prune minimally, back to their rear fencing-line/boundary, thus by about 1m; 3 - the most easterly of the 3 Conifers, being about 16.5m high, & 45cm diameter, we'd like to crown-lift on its northern side to 6m, thus creating a 'cavity-effect', as it overhangs their rear garden by some 6m; 4 - remove, by climbing, the 13.5m tall Sycamore tree, which overhangs the same garden by about 6m, to its middle area. This tree is completely suppressed by a huge Oak to its south-eastern side, so is very unbalanced on the overhang side, so it would likely be best to remove it now whilst young.
