

Whiteley Parish Appraisal 2004

Message from the Appraisal Team...

In the summer of 2002, Wickham Parish Council, supported by local organisations, agreed to undertake a Parish Appraisal, Whiteley Parish Council took over their section when the new Parish Council was created in May 2003. The aim was to identify local problems and issues of concern for residents and to build an action plan to address the findings.

This newsletter summarises the results of the questionnaire, provides some additional information from the Census and outlines the plans for action.

It has been a larger task than expected and the team is very grateful for the help from residents particularly in the delivery and collection of questionnaires.

Introduction

In April 2003 every household in the Winchester City Council ward of Whiteley received a questionnaire: 1060 were delivered and 405 returned. This report uses the questionnaire results as these are clearly auditable. Other information gathering exercises were also carried out including focus groups and 'on street' surveys with young people.

Household

The statistics for this section have, in part, been taken from the 2001 National Census results; comparisons with Winchester District and national statistics have been made where it is felt to be useful.

In 2001 there were 915 households in Whiteley with a resident population of 2,195, although additional houses have been built since this survey, the 2001 results are thought to be a fair representation of the current population.

Whiteley has a comparatively young population with an average age of 31 compared with 40 for Winchester District and 38 nationally. The age structure provided by the 2001 census is shown below:

The Census shows that the majority of housing is owner-occupied (87%) which is much higher than the average for Winchester District (70.5%) and nationally (69%). Car ownership is also high, 58% of households having two or more cars or vans compared with 45% for Winchester District and 29% nationally. Only 2.3% of the population of Whiteley have no car compared with 15.7% for Winchester District and 26.8% nationally.

The questionnaire shows that the main reason for living in Whiteley is for work and availability of housing.

13 respondents felt they were in need of alternative accommodation, 4 households felt their houses to be too small. 4 respondents had members of their households wanting to set up independent homes. 4 respondents required affordable housing for single, 3 households required affordable housing for families.

Education


2001 National Census figures show there to be 472 children under the age of 16 and 55 aged 16-19. 82% of respondents felt the primary school was an important focal point for the community.

3 families reported that they have been unable to secure local pre-school places for their children and 3 families reported refused places at Whiteley Primary, as there were no school places available.

Some children are unable to take part in after-school activities, 13 households feel the distance between home and school to be a problem, 8 the lack of transport and 6 the expense of activities.

112 households expressed an interest in attending further education with the majority, 74, looking for classes in computer skills and 25 interested in GCSE exam classes.

Employment

The 2001 National Census shows that the proportion of people in employment, at 83.7%, is well above the national (60.6%) and local (64.7%) average. Of the remainder, only 4.8% regard themselves as retired (national average 13.7%) and 5.4% are at home, looking after home and family (about average).

The Census also reveals that the unemployment rate is low at 1.4%, which helps to hold down the Winchester rate of 1.6% and compares with the national average of 3.4%.

Of those that responded 25% work in the retail/service industry, 24% are public sector workers and 13% work in IT/communications. Of the remaining jobs, technology is more prevalent than manual work.


69 households reported barriers to employment; 23 noting the lack of affordable childcare, 16 the lack of transport and 10 the lack of local childcare 67% felt a local job advertising board would be helpful.

A number of respondents have an interest in local job training opportunities, the most popular being IT/computers, then management, clerical/secretarial and construction/trade.




Transport and Travelling

The majority of residents travel between 1 and 15 miles to work, with 16% travelling 40 or more miles. The main means of transport to work is car (88%) with only 3% using the train and 4% walking.

105 households responding to the questions asking for problems using public transport stated that routes and timetables were the main areas of concern.

Households not using public transport also highlighted routes as a reason why it wasn't used.

What is your household's main means of transport to school? 138 households responded to this question



131 households responded to the question asking for comments on improvements needed to make public transport more attractive. The main issues being the need for more easily accessible and frequent services with direct access to Fareham, Portsmouth, Southampton and also the railway station at Swanwick.

Road Safety

205 households made comments on the areas of Whiteley where roads were considered to be excessively dangerous for drivers or pedestrians. Most roads are mentioned! 53 respondents mentioned Parkway, 21 the Marjoram Way roundabout and 16 Whiteley Way.

The questionnaire also asked where speeding traffic was considered to be a problem, 127 responded, 40 mentioned Whiteley Way, 32 Parkway, 16 Marjoram Way and 15 Leafy Lane, 10 said everywhere and 9 felt there to be no problem areas.

Health and Well-being

90 households responded to the question about difficulties reaching health care facilities: 55 mentioned difficulties reaching a dentist, 35 were unable to find an NHS dentist. 34 respondents had difficulty reaching a doctor with 17 stating the lack of available appointments as a problem; a further 23 had problems reaching hospital.

The questionnaire asked for opinions of the health services, the majority are happy, rating the services as good.


37 respondents have someone in their household with a health problem that affects day-to-day living, 6 feel their house needs adapting for health needs; 30 households have child-care help from a friend or relative.

When asked what advice or help would be useful 64 households responded, of these, the majority (28) would like advice about diet, healthy eating and weight control. Smaller numbers of people would like advice about exercise (9), smoking (7) and managing a household budget (6).


Do you consider any of these to be a problem? 188 households highlighted issues






Environment

276 households responded to the question asking for requests for environmental improvements. 131 would like more litter bins, 120 more dog bins. Traffic calming and the removal of unnecessary sign posts both had 94 requests; the need for recycling facilities, community compost facilities and more cycle paths were also highlighted.

Likes and Dislikes

Clean, safe, open spaces are the prominent features for residents living in Whiteley; however the access by only one road and the lack of facilities also cause residents concern.

How should the results of the survey be published?

The majority of households asked for a newsletter to each household.

Young People

Hampshire Youth Service designed and carried out a survey with the help of Parish Councillors to look at the needs and aspirations of young people. The views of 26 young people were recorded.


The majority of respondents attended Henry Cort School and were planning to continue their education beyond year 11.

Most of those surveyed considered themselves to be in good or very good health with three reporting asthma to be a problem and three admitting to smoking.


The majority reported exercising for more than 20 minutes three times a week with swimming, gym, football and dancing proving popular activities.

Nine respondents were concerned about crime and antisocial behaviour in the Parish with the threat of mugging worrying 7 young people. Seven of those surveyed say they had been a victim of crime with 4 saying they have committed a criminal offence.


How do you spend your leisure time? 18 young people responded to this question in the survey

The young people were asked for their likes and dislikes about their area. Friends and the open spaces are seen as advantages, the main drawback being the lack of things to do causing boredom. Pleas were made to ensure the grass is cut regularly in the play areas, a problem that has since been resolved.
