ROAD TRAFFIC REGULATION ACT 1984

THE HAMPSHIRE (VARIOUS ROADS, WINCHESTER) (PARKING PLACES AND RESTRICTION OF WAITING) (CONTROLLED ZONE) (CONSOLIDATION) ORDER 2010 (VARIATION NO.75) ORDER 2023

AND

THE HAMPSHIRE (VARIOUS ROADS, WINCHESTER) (PARKING PLACES AND RESTRICTION OF WAITING) (NO.2) ORDER 2002 (VARIATION NO.41) ORDER 2023

Winchester City Council acting on behalf of Hampshire County Council in exercise of its powers and duties under Sections 1, 2, 4, 32, 35, 45, 46, 49, 51, 53 and 122(1) and (2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") as amended by the Road Traffic Regulation (Parking) Act 1986 and of all other enabling and amending legislation and powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following order :-

CITATION

1. This Order shall come into operation on _____ 2023 and may be cited as The Hampshire (Various Roads, Winchester) (Parking Places and Restriction of Waiting) (Controlled Zone) (Consolidation) Order 2010 (Variation No. 75) Order 2023 and The Hampshire (Various Roads, Winchester) (Parking Places and Restriction of Waiting) (No.2) Order 2002 (Variation No. 41) Order 2023.

INTERPRETATION

2. In this order the "Principal Order" means "The Hampshire (Various Roads Winchester) (Parking Places and Restriction of Waiting) (Controlled Zone) (Consolidation) Order 2010' and "No.2 Order" means "The Hampshire (Various Roads, Winchester) (Parking Places and Restriction of Waiting) (No.2) Order 2002".
3. In this order "the Council" shall mean Hampshire County Council, or, as the case may be, Winchester City Council acting as Hampshire County Council's agents.

AMENDMENTS

4. The No.2 Order shall have effect as though a new Article 17 (iii) is added:
"(iii) between the hours of 8am to 10pm Monday to Saturday (inclusive) on any of the sides of the road specified in Schedule XIV of this Order."

5. The No.2 Order shall have effect as though the items specified in Schedule 1 to this Order, shall be inserted into the No.2 Order as the new Schedule XIV - 8am to 10pm Monday to Saturday (inclusive).
6. The No.2 Order shall have effect in that the items specified in Schedule 2 of this Order shall be deleted from Schedule II of the No.2 Order.
7. The No.2 Order shall have effect in that the items specified in Schedule 3 of this Order shall be inserted in Schedule II of the No.2 Order.
8. The Principal Order shall have effect in that the items specified in Schedule 4 of this Order shall be deleted from the Schedules specified of the Principal Order.
9. The Principal Order shall have effect in that the items specified in Schedule 5 of this Order shall be inserted into Schedule 1 Pt II of the Principal Order.
10. The Principal Order shall have effect as though the items specified in Schedule 6 of this Order shall be inserted into Schedule I Part XXXVIV of the Principal Order.
11. The Principal Order shall have effect as though the items specified in Schedule 7 of this Order shall be inserted into Schedule 2 of the Principal Order.
12. The Principal Order shall have effect as though the items specified in Schedule 8 of this Order shall be inserted into Schedule 4 of the Principal Order.
13. The Principal Order shall have effect as though the items specified in Schedule 9 to this Order, shall be inserted into the Principal Order as the new Schedule 1 Pt XLVI - Electric vehicle charging bay only (at any time).
14. The Principal Order shall have effect as though a new Article 1.7.1 is added:

“electric vehicle“ means a motor vehicle partly or wholly propelled by electricity which requires recharging via connection to an external electricity supply.
