All three trees have been retained as long as safely possible but they now have a very poor appearance and we are concerned about safety in view of the auto amputation of

large limbs.

The proposal is to safely fell and dispose of all three trees.

We have many remaining trees and so the overall aesthetics of the area will be

maintained, indeed improved by the removal of the diseased T1, T2, T3
