Please provide me with the following information under the Freedom of Information Act.

- How many electric vehicle chargers have been installed in your council area, including on streets, motorways and car parks? If you could provide a breakdown over the past 5 years (preferably calendar year).
- How many broken chargers have had to be fixed over the last 5 years and what has been the cost of this? If you could provide a breakdown over the past 5 years (preferably calendar year).
- How many electric vehicle chargers do you plan to install in 2024?
- How many electric vehicle chargers do you plan to install in 2025? (If applicable)

If it is not possible to provide some of the data requested, I would be grateful if you could provide whichever elements of this FOI request are eligible for release.

Therefore, if it is possible to ascertain within the prescribed time limit, without having to provide a fee for further investigations, please respond in electronic form with all the information above

All of the above were installed in 2020 with the exception of Winchester Sport & Leisure (2021), Barfield Phase II (2022), and Alresford Station (2023).

The number of breakdowns over the last 5 years (according to my records) has been 3, with costs covered from our existing maintenance contract.

We are planning to install 3 additional units in 2024 but will also 'swap out' 4 existing 'fast' units for 'rapid' chargers.

It is unknown at this point whether any will be installed in 2025.
