Submission Update March 2016

This EqIA was prepared and published with the pre-submission Local Plan Part 2 for consultation during November – December 2015.

The following Recommended Actions were included:

- 1. Ensure policy wording is consistent, with particular reference to affordable housing.**
- 2. Explore appropriate mechanisms to ensure LPP2 is read in conjunction with LPP1.**
- 3. Consider detailed wording of DM16 – site development principles to include reference to promoting mixed and balanced communities.**
- 4. Re-assess the structure of the monitoring framework to allow for analysis of the impact of the policies/proposals in relation to equality groups.**

These matters will be picked up through the preparation of minor modifications during the examination process, taking into account any advice or recommendations by the Local Plan Inspector.

1 Introduction

- 1.1 Winchester District Local Plan Part 1 (LPP1) was adopted in March 2013, following extensive research and consultation, with both the public and stakeholders. LPP1 was subject to an Equalities Impact Assessment (EqIA) at key stages of its preparation, namely during 2009 at Preferred Option stage and again during 2011 at Pre-Submission. This picked up recommendations from the 2009 report and changes to the Council's Equality Policy during 2011. This iterative process ensured that LPP1 complied with equality matters.
- 1.2 The purpose of this EqIA is to examine the content of draft Local Plan Part 2 - Development Management and Site Allocations (LPP2), in terms of its likely impact on different community groups and how the needs of such groups have been taken into account in the evolution of the planning policies for the District. Therefore, the key question for this EqIA is: '***Does Local Plan Part 2 have the potential to cause adverse impact on or unlawfully discriminate against any groups in the community?***'

2 Background to Local Plan Part 2

- 2.1 The Council commenced preparation of LPP2 during 2013, working with Parish Councils, local communities and other organisations to determine and accommodate the development needs of the area, particularly the larger settlements that have a housing target to meet under policies in LPP1. In addition to allocating sites for development, LPP2, also includes a range of development management policies, which will be applied across the District when determining planning applications. These policies cover a variety of topics from conservation to design and shopping frontages to equestrian development. It should be noted that LPP2 does not cover that part of the District that lies within the South Downs National Park, this area will be covered by the Local Plan being prepared by the South Downs National Park Authority to be published in due course.
- 2.2 The preparation of LPP2 must comply with the National Planning Policy Framework (NPPF) 2012 and the Town and Country Planning (Local Planning) (England) Regulations 2012. Local Plan preparation covers set stages and the first formal stage falls under Regulation 18, during which the draft Plan was published for consultation for a six week period from 24 October to 5 December 2014. - 2.3 LPP2 is required to be in compliance with LPP1 and therefore the policies in LPP2 do not list or cross refer to other policies and should be read alongside LPP1 for completeness.

- 2.4 Given, this is the first time that the Plan in its entirety is available, it is an appropriate point at which to undertake an EqlA on the draft Plan's policies. This will allow any recommendations from this screening report to inform the final expression of policies and proposals prior to its publication in advance of its examination during 2016. Notwithstanding this, the emerging policies of LPP2 have been subject to a Sustainability Appraisal which includes references to:- building communities through the promotion of social inclusion; provide good quality housing for all; improve the health and well being of all. These pick up on some of the equality issues set out in the following sections.

4 Winchester City Council Equality Policy

- 4.1 In April 2011, the Council updated its Equality Policy, which sets out the Council's overall approach to equality as both an employer and a provider of services. It also covers the Council's approach to:
- partnership working on equality issues,
 - the "duty to involve" and the requirement to consult and engage with the local community,
 - the new public sector equality duties which came into force in April 2011.
- 4.2 The policies included in the document relate to all of the "protected characteristics" of equality as defined by the Equality Act 2010. These are:
- age
 - disability
 - gender reassignment (transgender)
 - marriage and civil partnership
 - pregnancy and maternity
 - race
 - religion or belief
 - sex (gender)
 - sexual orientation
- 4.3 The practical effect of the Act – together with other relevant legislation including the Human Rights Act 1998 and the Local Government Act 2000 - is that the Council is legally required to consider how its policies, plans, services, procedures, practices, projects, and decisions will affect people with the protected characteristics.
- 4.4 The City Council has published information that summarises key elements of equality/diversity matters. The information is organised under the 9 'Protected Characteristics' listed above. Also included is information on literacy and numeracy, benefits, and about the City Council's Housing service. 5 EqlA Scoping Assessment of draft Local Plan Part 2

- 5.1 The revised equality processes introduced by the Council in 2011, require a scoping and analysis template to be completed to assess any potential impacts on equality matters. This is set out below for the LPP2 taken as a whole and reveals that the majority of protected characteristics categories score positively or are not applicable. This is due to the varied nature of the document and that its policies and proposals are expressed over the long term to 2031 and primarily relate to the use of land. .

7 Summary and Conclusion

- 7.1 This screening assessment has not revealed any significant deficiencies in the expression of the policies and proposals in the draft Winchester District Local Plan Part 2 – Development Management and Site Allocations, in relation to equality matters.
- 7.2 Many policies refer to social inclusion and a number specifically apply to rural areas. Some also refer to specific types of development for certain sectors of the population – e.g. the elderly and gypsies and travellers. Given the strategic nature of the document, its District-wide coverage and long term application, equality issues are intrinsically incorporated, hence most of the scores above fall within the category of either positive impact or neutral/don't know.
- 7.3 An exercise of this kind is useful to examine the expression of policies in detail. This has highlighted that there are some inconsistencies between individual policies which are aimed at delivering similar outcomes. Of particular note and of relevance to this EqIA, is the reference to affordable housing in those policies allocating sites for housing purposes. Some policies include a section on 'Nature and Phasing of Development', particularly for more complex sites or mixed-use allocations. Where this is included, specific mention is made of the provision of affordable housing at the appropriate stage. There are however, some sites allocating substantial numbers of houses (over 100 dwellings) which do not include a section on 'Nature and Phasing of Development', these include BW3- The Vineyard/Tangier Lane Bishops Waltham and CC1- Main Road, Colden Common, whereas there are smaller sites which do include this section. Given the importance of the provision of affordable housing across the District, a consistent approach should be followed and the provision of affordable housing on all sites should be an integral part of the site planning process rather than an after thought.
- 7.4 LPP2 follows on from LPP1, which was adopted in March 2013 and includes strategic policies, establishing the distribution of development across the District and development principles to be followed. LPP2 policies are based on the strategy in LPP1 which was also subject to an [equality assessment](#).
- 7.5 The relationship between LPP1 and LPP2 is made clear in section 1 of LPP2, and is reiterated in section 6.1 at the start of the development management policies, there are no other reminders to the reader that policies in LPP2 must be read in conjunction with LPP1. This is of particular significance with reference to housing where Policy CP2 of LPP1 specifically refers to provision of a 'wide choice of homes' and 'specialist forms of accommodation'. Similarly the distribution policies in

LPP1 refer to 'support needs to ensure social inclusion'. It is acknowledged that it is not possible to cross reference to all policies and combinations of policies due to the number involved, however consideration should be given to stressing the need to read LPP2 in conjunction with LPP1.

Recommended Actions:

- 5. Ensure policy wording is consistent, with particular reference to affordable housing.**
- 6. Explore appropriate mechanisms to ensure LPP2 is read in conjunction with LPP1.**
- 7. Consider detailed wording of DM16 – site development principles to include reference to promoting mixed and balanced communities.**
- 8. Re-assess the structure of the monitoring framework to allow for analysis of the impact of the policies/proposals in relation to equality groups.**
