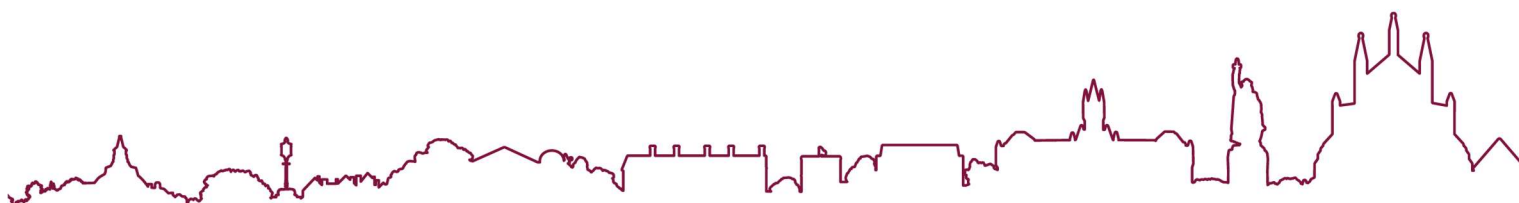

Request:

6. The detail requested is not able to be provided without a manual review of each applicable PCN case. To provide you with the information requested would require an officer to search, open and review each case to establish either ground of challenge or reason for cancellation and record/compile for a response. Section 12 of the Act makes provision for public authorities to refuse requests for information where the cost of dealing with them would exceed the appropriate limit which for local authorities is set at £450. This represents the estimated cost of one person spending 18 hours in determination.

We estimate that it would take us in excess of 18 hours to determine the information as requested and therefore we are unable to assist you with this part of this request.
