This notice sets out how Winchester City Council uses and protects any personal information that you give for the purpose of processing your application for Housing Benefit, Council Tax Reduction, an Exceptional Hardship Payment and a Discretionary Housing Payment.

Winchester City Council is committed to protecting and respecting the privacy of your personal data. We are registered with the Information Commissioner’s Office as a Data Controller (Reg. no.Z5730734) and we comply with the UK General Data Protection Regulation and the Data Protection Act 2018.

What personal information do we collect and what do we use it for?

Who we might share your information with?

Your personal information will be treated as confidential, but it may be shared with other council departments in order to provide services, meet our legal obligations, ensure our records are accurate and up to date and improve the standard of the services we deliver. It may also be shared with external organisations involved in delivering services on our behalf where the Council has a lawful basis to do so. We will only use your information in ways which are permitted by the UK General Data Protection Regulation and the Data Protection Act 2018.

- DWP and local authorities often work together and share information to provide services. DWP and Winchester City Council local authorities are joint data controllers for Housing Benefit and

- Winchester City Council has a duty to protect the public funds it administers and may use the information you have provided or share it with other bodies for the purpose of preventing and detecting fraud. This includes participation in the Cabinet Office National Fraud Initiative.
- We will NOT use your personal data for marketing products or services.

How long do we keep your data for?

We keep your personal information for as long as we need to for the purposes we collected it for, including for the purpose of satisfying any legal, accounting or reporting requirements or to fulfil statutory obligations. For Benefits purposes, this is usually 7 years.
