NOTICE IS HEREBY GIVEN that Upham Parish Council has submitted the Upham Village Design Statement (UVDS) to the South Downs National Park Authority and Winchester City Council to be adopted as a Supplementary Planning Document. If adopted, the UVDS will provide design guidance for development in Upham, supplementing Policies SD4 and SD5 in the South Downs Local Plan, and Policies CP13 and DM15 in the Winchester Local Plan (Parts I & 2). The Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended), the South Downs Statement of Community Involvement (April 2022), and the Winchester City Council Statement of Community Involvement (January 2024), altogether, require the local planning authorities to carry out a minimum of 6 weeks' public consultation, inviting comments from any interested party on the UVDS.
