- Revenue budget is set and linked to the contract we have with biffa, which changes with inflation and number of properties. But is around £5.5million in terms of expenditure.

- The indicative funding we have received from PACK UK via the notification letter earlier in the year is 1.68m, which will go into the central corporate revenue budget.
- We have recently replied to a letter from PACK UK confirming our intention to use the funding on the cost of waste and recycling.

- Winchester as all the WCA's in Hampshire is currently recycling the materials which go into the Hampshire MRF's set up by Project Integra. The County has planning permission for a new single material recycling facility to take all the required materials under Simpler Recycling, but building has not started yet, and currently the planned opening date is early 2028
- Glass bottles and jars used as packaging;
