1 Number of Licensed Dog Breeders at 31/03/25

Response

1. There are 11 licensed breeders at 31/03/25, 3 one year licences, 2 two year licences, 6 three year licences.
2. Applications for dog breeding licences received (between 01/04/24 and 31/03/25);
(A) 3 were new applications, all were granted.
(B) 8 were renewals, all were granted.
3. Inspections undertaken in relation to holders of dog breeding licences between 01/04/24 and 31/03/25
(a) Initial inspections for new = 3, interim compliance inspections = 0
(b) Initial inspections for renewal = 2, interim compliance inspections = 2
4. Complaints received about dog breeding between 01/04/24 and 31/03/25
(a) 1 complaint against licensed breeder, resulted in 1 follow-up inspection, 1 licence was suspended and 1 subsequent visit. No licences revoked.
(b) 5 complaints about unlicensed breeders, 4 visits made.
5. Enforcement actions in relation to dog breeding licence holders between 01/04/24 and 31/03/25. 1 suspension of licence for breach of licensing conditions. No revocations, no prosecutions, no FPNs, no improvement notices.
