We consider details of the full last known address of the deceased to be exempt under section 31 of the Freedom of Information Act (prevention and detection of crime) as this address, if unoccupied might still contain the deceased's personal effects. There is an inherent strong public interest in avoiding likely prejudice to the prevention of crime.
