TEMPORARY ROAD CLOSURES – VARIOUS ROADS, WINCHESTER DISTRICT.

NOTICE IS HEREBY GIVEN that Winchester City Council as agents for Hampshire County Council has made an Order on traffic management grounds to allow for routine maintenance works to be carried out as follows:-

ROADS TO BE CLOSED:

1.AIRLIE ROAD, WINCHESTER.

Planned approx.2day duration for carriageway repairs between its junction with Sparkford Road and its junction with Ranelagh Road.

2.SPARKFORD ROAD, WINCHESTER.

Planned approx.3day duration for carriageway repairs between its junction with St. James Lane and its junction with Airlie Road.

3.CHURCH LANE, KINGSWORTHY.

Planned approx.5day duration for carriageway repairs between its junction with London Road and its junction with Nations Hill.

4.WATLEY LANE, SPARSHOLT.

Planned approx.2day duration for carriageway repairs between its junction with Church Road and its junction with Stockbridge Road.

5.CHAPEL LANE, ITCHEN VALLEY.

Planned approx.1day duration for carriageway repairs between its junction with Easton Lane and its junction with Alresford Road(Percy Hobbs).

6.TITHELANDS LANE, BRAMDEAN.

Planned approx.5day duration for carriageway repairs between its junction with A272 Petersfield Road and its junction with Old Park Road.

7.KILMESTON ROAD, CHERITON.

Planned approx.2day duration for carriageway repairs between its junction with A272 Petersfield Road and its junction with Grays Farm Close.

8.KILMESTON ROAD, KILMESTON.

Planned approx.5day duration for carriageway repairs between its junction with Beacon Hill Road and its junction with Down Lane.

9.LONGWOOD, TICHBORNE/OWSLEBURY.

Planned approx.1day duration for carriageway repairs between its junction with Lane End Road and its junction with Belmore Lane.

10.LIPPEN LANE, WEST MEON.

Planned approx.4day duration for carriageway repairs between its junction with Riverdown Road and its junction with Polly Glovers Lane.

11.ALLENS LANE, CORHAMPTON AND MEONSTOKE.

Planned approx.2day duration for carriageway repairs between its junction with A32 Warnford Road and its junction with Rectory Lane.

12.CROSS LANE, UPHAM.

Planned approx.1day duration for carriageway repairs between its junction with Stakes Lane and its junction with Ashton Lane.

13.UPHAM STREET, UPHAM.

Planned approx.4day duration for carriageway repairs between its junction with Popes Lane and its junction with Elm Crescent.

14.MINCINGFIELD LANE, DURLEY.

Planned approx.2day duration for carriageway repairs between its junction with Kytes Lane and its junction with Mill Lane.

15.ASHTON LANE, BISHOP'S WALTHAM.

Planned approx.1day duration for carriageway patching between its junction with Chapel Farm Lane and its junction with Beeches Hill.

16.DEAN LANE, BISHOPS WALTHAM.

Planned approx.1day duration for carriageway repairs between its junction with Beeches Hill and its junction with Stakes Lane.

17.WANGFIELD LANE, CURDRIDGE.

Planned approx.2day duration for carriageway repairs between its junction with Maddoxford Lane and its junction with Vicarage Lane.

18.CALCOTT HILL, CURDRIDGE.

Planned approx 2week duration for highway drainage improvements between its junction with Mill Hill and its junction with Blind Lane.

19.CHURCH ROAD, SWANMORE.

Planned approx.5day duration for drainage improvements and carriageway resurfacing between its junction with New Road and its junction with Vicarage Lane.

20.DODDS LANE, SWANMORE.

Planned in connection with the above resurfacing work in Church Road from its junction with Vicarage Lane for a distance of 50 metres eastwards.

21.LOWER CHASE ROAD, SWANMORE.

1. Planned 13th Nov.2008 for approx.5day duration to enable a Gas service installation between its junction with Brook Lane and its junction with Ludwell Lane.

2. Planned approx. further 5day duration for highway drainage improvements between its junction with Brook Lane and its junction with Swanmore Road

22.VICARAGE LANE, SWANMORE.

Planned approx.2week duration for highway drainage improvements between its junction with Church Road and its junction with Well Lane.

23.MISLINGFORD ROAD, SWANMORE.

Planned approx.4day duration for verge/carriageway repairs between its junction with Hill Pound and its junction with Bishop's Wood Road.

24.COTT STREET, SWANMORE.

Planned approx.1day duration for carriageway repairs between its junction with Dirty Copse Lane and its junction with Cott Street Lane.

25.SELWORTH LANE, SOBERTON.

Planned approx.3day duration for carriageway repairs between its junction with High Street and its junction with A32, Wickham Road.

26. HEATH ROAD, SOBERTON.

Planned approx. 1 day duration for carriageway repairs between its junction with A32, Droxford Road and its junction with Horns Hill.

27. FRITH LANE, WICKHAM.

Planned approx. 2 week duration for highway drainage improvements between its junction with Hospital Road and its junction with Blind Lane.

ALTERNATIVE ROUTES: Alternative routes will be signposted at the time of closure. Individual road closures in the same area will be implemented consecutively and not simultaneously.

PERIOD OF CLOSURE: The closures are enforceable between the 16th October 2008 and the 30th April 2009 or until the completion of the works whichever is sooner. (Notwithstanding the above, it is expected that the closure of each individual road will only be required for between 1 and 20 working days. **With the exception of any emergency works, advance warning signs will be displayed approximately 2 weeks in advance of any road closure being enforced.**

Reasonable facilities will be provided to allow access to adjacent premises while the work is being carried out. Letters will be sent to properties affected at the appropriate time notifying them of the detailed arrangements.
