NOTICE IS HEREBY GIVEN that Winchester City Council as agents for Hampshire County Council proposes to make an order on traffic management grounds to allow for routine maintenance works to be undertaken as follows:

ROADS TO BE CLOSED:

- 1. <u>College Street</u>, Winchester between its junction with Kingsgate Street and its junction with College Walk. (anticipated period of 5 days)
- 2. <u>Kingsgate Street</u>, Winchester between its junction with College Street and its junction with Romans Road. (anticipated period of 5 days)
- 3. <u>Canon Street</u>, Winchester between its junction with Kingsgate Street and its junction with Culver Road. (anticipated period of 3 weeks)
- 4. <u>Staple Gardens</u>, Winchester for its entire length. (anticipated period of 5days)
- 5. <u>Tower Street</u>, Winchester between its junction with Tower Road and its junction with Staple Gardens. (anticipated period of 5 days)
- 6. <u>St Mary Street</u>, Winchester between its junction with Cromwell Road and its junction with Stuart Crescent. (anticipated period of 5 days)
- 7. <u>Cromwell Road</u>, Winchester between its junction with Airlie Road and its junction with The Valley. (anticipated period of 5 days)
- 8. Stuart Crescent, Winchester for its entire length. (anticipated period of 5 days)
- 9. Forbes Road, Kings Worthy for its entire Length.(anticipated period of 5 days)
- 10. <u>Trussell Crescent</u>, Winchester for its entire Length. (anticipated period of 5 days)
- 11. <u>Hensting Lane</u>, Colden Common, between its junction with Main Road and its junction with Whites Hill. (anticipated period of 10 days)
- 12. Manor Road, Durley for its entire length. (anticipated period of 5 days)
- 13. <u>Kytes Lane</u>, Durley for its entire length. (anticipated period of 5 days)
- 14. Durley Brook Road, Durley for its entire length.(anticipated period of 2 days)
- 15. <u>Longwood Road</u>, Owslebury between its junction with Belmore Lane and its junction with Longwood Dean. (anticipated period of 5 weeks)
- 16. Whaddon Lane, Owslebury between its junction with Lower Baybridge Lane and its junction with Main Road. (anticipated period of 5 days)
- 17. <u>Ashton Lane</u>, Bishops Waltham between its junction with Winchester Road and its junction with Cross Lane. (anticipated period of 3 weeks)
- 18. <u>Beeches Hill</u>, Bishops Waltham between its junction with Dean Lane and its junction with Little Ashton Lane. (anticipated period of 4 weeks)
- 19. <u>Stocks Lane</u>, Meonstoke between its junction with Alton Road and its junction with Rectory Lane. (anticipated period of 2 days)
- 20. <u>Kiln Hill</u>, Soberton between its junction with Ingoldfield Lane and its junction with May Bush Lane. (anticipated period of 5 days)
- 21. <u>Cole Hill</u>, Soberton between its junction with High Street and its junction with West Street. (anticipated period of 3 weeks)
- 22. <u>Hospital Road</u>, Shirrell Heath, between its junction with High Street and its junction with Newmans Hill. (anticipated period of 3 weeks)
- 23. <u>Gravel Hill</u>, Shirrell Heath between its junction with Bishopswood Road and its junction with Hospital Road. (anticipated period of 3 weeks)

- 24. <u>Frith Lane</u>, Wickham between its junction with Mill Lane and its junction with Hospital Lane. (anticipated period of 5 days)
- 25. <u>Mill Lane</u>, Wickham between its junction Frith & Blind Lane and its junction with Station Road. (anticipated period of 4 weeks)
- 26. <u>Biddenfield Lane</u>, Soberton between its junction with Tichfield Lane and its junction with Botley Road. (anticipated period of 5 days)
- 27. <u>Fareham Road</u>, Hambledon between its junction with Hambledon Road and its junction with Uplands Road. (anticipated period of 3 weeks)
- 28. <u>Closewood Road</u>, Denmead between its junction Hambledon Road and its junction with Newlands Road. (anticipated period of 3 weeks)
- 29. <u>Portsdown Hill Road</u>, Southwick between its junction with Skew Road and its junction with Swivelton Lane. (anticipated period of 3 weeks)
- 30. <u>Purbrook Heath Road</u>, Purbrook between its junction with London Road and its junction with Newlands Road.(anticipate period of 2 days)
- 31. Newlands Road, Purbrook between its junction with Purbrook Heath Road and its junction with Closewood Road. (anticipated period of 2 days)

ALTERNATIVE ROUTES:

Alternative routes will be signposted at the time of closure. Individual road closures in the same area will be implemented consecutively and not simultaneously.

PERIOD OF CLOSURE:

From 3 August 2009 for a period of 12 months or until completion of the works. With the exception of any emergency works, advance warning signs will be displayed approximately 2 weeks in advance of any road closure being enforced.

Reasonable facilities will be provided to allow access to adjacent premises while the work is being carried out.
