2. "The Hampshire (Alresford Drove and Old Stoke Road, South Wonston) Traffic Regualtion Order 2010."

The effect of this order proposals for which were advertised on 29th July 2010 will be to introduce a weight limit of 7.5 tonnes maximum gross weight for Alresford Drove from its junction with Westhill Road and a point 240 metres east of that junction and for Old Stoke Road from its junction with Wonston Road to a point 194.0 metres south of that junction.

Each of the above orders will come into operation on 29th October 2010 Copies of the orders, maps showing the locations and a statement of reasons for each of the above orders and the orders to be varied may be inspected during usual office hours at the City Offices, Colebrook Street, Winchester. Any person who wishes to question the validity of any of the above orders or any of the provisions of the orders on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under it has not been complied with may, within six weeks of the date when the orders were made apply to the High Court for that purpose.
