TEMPORARY ROAD CLOSURE - VARIOUS ROADS - 12/13 NO. 3

NOTICE IS HEREBY GIVEN that Winchester City Council as agents for Hampshire County Council proposes to make an order on traffic management grounds to allow for routine maintenance works to be undertaken as follows:

ROADS TO BE CLOSED:

- 1. Big Tree Cottages, Soberton for its entire length.
- 2. Cott Street, Swanmore between A32 Wickham Road and Droxford Road.
- 3. <u>Cricklemede, Bishops Waltham</u> between Hoe Road and Shore Lane.
- 4. Free Street, Bishops Waltham between Hoe Road and Lower Lane.
- 5. <u>Hampton Hill, Swanmore</u> between Swanmore Road and Well Lane.
- 6. Harvest Road, Denmead for its entire length.
- 7. Mill Lane, Wickham between Bridge Street and Blind Lane.
- 8. Pit Hill Lane, Hambledon between Rushmere Lane and Harrowgate Lane.
- 9. Pithill Farm Lane, Hambledon between Harrowgate Lane and Kidmore Lane.
- 10. Shore Lane, Bishops Waltham between Coppice Hill and Bank Street.
- 11. Spring Gardens, New Alresford between New Farm Road and Alresford Road.

ALTERNATIVE ROUTES:

- 1. Big Tree Cottages, Soberton none.
- 2. <u>Cott Street, Swanmore</u> A32 Wickham Road, Bishops Wood Road, Gravel Hill, Hill Pound, Droxford Road.
- 3. Cricklemede, Bishops Waltham Hoe Road, Shore Lane.
- 4. <u>Free Street, Bishops Waltham</u> Lower Lane, Corhampton Road, Winchester Road, Coppice Hill, Shore Lane, Hoe Road.
- 5. <u>Hampton Hill, Swanmore</u> Well Lane, Vicarage Lane, Church Road.
- 6. Harvest Road, Denmead none.
- 7. Mill Lane, Wickham Blind Lane, A334 Winchester Road, The Square, Bridge Street.
- 8. Pit Hill Lane, Hambledon Rushmere lane, Harrowgate Lane.
- 9. <u>Pithill Farm Lane, Hambledon</u> Harrowgate Lane, Rushmere lane, B2150 Hambledon Road, Kidmore Lane.
- 10. <u>Shore Lane, Bishops Waltham</u> Hoe Road, Swanmore Road, Lower Chase Road, Winchester Road.
- 11. <u>Spring Gardens, New Alresford</u> Alresford Road, Winchester Road, New Farm Road.

Alternative routes will be signposted at the time of closure. Individual road closures in the same area will be implemented consecutively and not simultaneously.

PERIOD OF CLOSURE:

From 4th April 2012 for a period of 12 months or until completion of the works.

Each road is only expected to be closed for the minimum period to facilitate the works. Exact durations will be notified on site.

With the exception of any emergency works, advance warning signs will be displayed approximately 2 weeks in advance of any road closure being enforced.

Reasonable facilities will be provided to allow access to adjacent premises while the work is being carried out.
