NOTICE IS HEREBY GIVEN that Winchester City Council as agents for Hampshire County Council has made an order on traffic management grounds to allow for routine maintenance works to be undertaken as follows:

ROADS TO BE CLOSED:

- 1. Calcot Hill, Durley between its junction Mill Lane and its junction with Botley Road.
- 2. <u>Chancellors Lane, Durley</u> between its junction with the B3354 Winchester Road and its junction with Stapleford Lane.
- 3. <u>Church Lane, Durley</u> between its junction with Greenwood Lane and its junction with Snakemoor Lane.
- 4. <u>Cockpit Lane/Durley Road, Durley</u> between its junction with Greenwood Lane and its junction with Knowle Lane.
- 5. <u>Durley Brook Road, Durley</u> between its northern junction with Snakemoor Lane and its junction with Parsonage Lane.
- 6. <u>Greenwood Lane, Durley</u> between its junction with Alma Lane and its junction with Church Lane.
- 7. <u>Heathen Street, Durley</u> between its junction with Stapleford Lane and its junction with Parsonage Lane.
- 8. <u>Kytes Lane</u>, <u>Durley</u> between its junction with Parsonage Lane and its junction with Mincingfield Lane.
- 9. <u>Manor Road, Durley</u> between its junction with Durley Street and its junction with Mincingfield Lane.
- 10. <u>Mill Lane, Durley</u> between its junction with Netherhill lane and its junction with Mincingfield Lane.
- 11. Netherhill Lane, Durley between its junction with Wangfield Lane and its junction with Mill Lane.
- 12. <u>Netherhill Lane, Durley</u> between its junction with Mill Lane and its junction with Chancellors Lane.
- 13. <u>Sciviers Lane, Durley</u> between its junction with the B2177 Winchester Road and its junction with Durley Street.
- 14. <u>Snakemoor Lane, Durley</u> between its junction with the B3354 Winchester Road and its junction with Durley Brook Road.

Alternative routes will be signposted at the time of closure. Individual road closures in the same area will be implemented consecutively and not simultaneously.

PERIOD OF CLOSURE:

From 1st April 2013 for a period of 12 months or until completion of the works.

Each road is only expected to be closed for the minimum period to facilitate the works. Exact durations will be notified on site.

With the exception of any emergency works, advance warning signs will be displayed approximately 2 weeks in advance of any road closure being enforced.

Reasonable facilities will be provided for access to adjacent premises while the work is being carried out.
