NOTICE IS HEREBY GIVEN that Winchester City Council as agents for Hampshire County Council proposes to make an order on traffic management grounds to allow for routine maintenance works to be undertaken as follows:

ROADS TO BE CLOSED:

- 1. <u>A32 Alton Road, Warnford</u> between its junction with Hayden Lane and its junction with Wheely Down Road..
- 2. <u>Ashton Lane, Bishops Waltham</u> between its junction with Beeches Hill and its junction with Street End.
- 3. <u>Badshear Lane, Cheriton</u> between its junction with Northend Lane and its junction with Cheriton Lane.
- 4. <u>Beech Grove, Owslebury</u> for its entire length.
- 5. <u>Bishopstoke Lane, Colden Common</u> between its northern junction with Church Lane and its junction with Stoke Common Road.
- 6. <u>Boyatt Lane, Otterbourne</u> between its junction with Park Lane and its junction with Bosville.
- 7. <u>Elm Crescent, Upham</u> for its entire length.
- 8. <u>Northend Lane, Cheriton</u> between its junction with the B3046 Cheriton Road and its junction with Badshear Lane.
- 9. <u>High Street, West Meon</u> between its junction with the A32 Alton Road and its junction with Vinnells Lane.
- 10. <u>Hoe Road, Bishops Waltham</u> between its junction with Cricklemede and its junction with Swanmore Road.
- 11. <u>Main Road, Colden Common</u> between its junction with Avon Close and its junction with New Road.
- 12. <u>Swanmore Road, Bishops Waltham</u> between its junction with Hoe Road and its junction with Moorlands Road.
- 13. <u>West Street, New Alresford</u> between its junction with Jacklyns Lane and its junction with Broad Street.

- 10. <u>Hoe Road, Bishops Waltham</u> Cricklemede, Shore Lane, Lower Chase Road, Swanmore Road.
- 11. Main Road, Colden Common Main Road, Church Road, Highbridge Road, Main Road.
- 12. <u>Swanmore Road, Bishops Waltham</u> Hoe Road, Cricklemede, Shore Lane, B2177 Winchester Road, Lower Chase Road, Swanmore Road.
- 13. <u>West Street, New Alresford</u> Pound Hill, The Avenue, A31 Alresford Bypass, Bishops Sutton Road, East Street

Alternative routes will be signposted at the time of closure. Individual road closures in the same area will be implemented consecutively and not simultaneously.

PERIOD OF CLOSURE:

From 1st April 2013 for a period of 12 months or until completion of the works.

Each road is only expected to be closed for the minimum period to facilitate the works. Exact durations will be notified on site.

With the exception of any emergency works, advance warning signs will be displayed approximately 2 weeks in advance of any road closure being enforced.

Reasonable facilities will be provided for access to adjacent premises while the work is being carried out.
