The effect of this proposal will be to revoke the provisions relating to Chesil Surface Car Park and remove it and any reference to it from the Order. Any permit or season ticket which relates to Chesil Surface Car Park will be varied to remove it the residents off street (off peak) Car park season ticket will be varied to include Chesil Multi Storey Car Park instead of the Surface car park

NB: Both of the above proposals are conditional on the Chesil Extra Care Scheme going ahead. All comments and objections to these proposals will be considered in accordance with the normal Council policies and statutory procedures for Traffic Regulation Orders.
