Notice of Making of Various Road Traffic Regulation Orders Affecting the District of Winchester City Council

On 7th November 2014 Winchester City Council as agents for Hampshire County Council made the undermentioned road traffic regulation orders:-

1. The Hampshire (A31 Alresford Road, A31 Petersfield Road And A272 Petersfield Road, Winchester) (Temporary 40 Miles Per Hour Speed Limit) Order 2014

The effect of this order, proposals for which were advertised on 9th July 2014, will be to introduce a permanent 40 mile per hour speed limit on the A31 Alresford Road, Winchester and the A272 Petersfield Road, Winchester.

2. The Hampshire (Various Roads Winchester) (Parking Places and Restriction of Waiting) (Controlled Zone) (Consolidation) Order 2010 (Variation No. 20) Order 2014

The effect of this order, proposals for which were advertised on 9th July 2014, will be to introduce no waiting at any time provision in Hatherley Road, Winchester. Details are as follows:-

3. The City of Winchester (Central Area) Traffic Regulation (Consolidation) Order 1984 (Variation No. 2) Order 2014

The effect of this order, details of which were advertised on 9th July 2014, will be to remove the one way traffic flow direction in Market Lane, Winchester and introduce a 6.0 ft width restriction in Great Minster Street, Winchester. Details are as follows:-

One Way Traffic in Market Lane, Winchester (that length of road which extends from its junction with Market Street to its junction with Paternoster Row) to be revoked and to introduce a 6' 0" width restriction in Great Minster Street, Winchester for its entire length with no exception for access.

4. The Hampshire (Various Roads Winchester) (Parking Places And Restriction Of Waiting) (Controlled Zone) (Consolidation) Order 2010 (Variation No. 23) Order 2014

The effect of this order, details of which were advertised on the 5th August 2014, will be to remove the residents parking provisions and no waiting provisions from Erskine Road, Winchester and Peninsular Road, Winchester.

Each of the above orders will come into operation on 1st December 2014.

Copies of the orders, maps showing the locations and a statement of reasons for each of the above orders and the orders to be varied may be inspected during usual office hours at the City Offices, Colebrook Street, Winchester.

Any person who wishes to question the validity of any of the above orders or any of the provisions of the orders on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under it has not been complied with may, within six weeks of the date when the orders were made apply to the High Court for that purpose.
