

# **TRAFFIC REGULATION ORDER**

Notice of Proposals of making of Various Road Traffic Regulation Orders
<u>Affecting the District of Winchester City Council</u>

Winchester City Council as agents for Hampshire County Council proposes making the undermentioned road traffic regulation orders:-

### 1. The Hampshire (Southwick) (Prohibition of Right and Left hand turn) Revocation Order 2014

The effect of this order will be revoke the existing right turn ban at the High Street/Priory Road Junction of Southwick and enable the installation of a mini roundabout at this junction.

### 2. The Hampshire (Various Roads, Alresford) (Restriction of Waiting) Order 1998 (Variation No. 4) Order 2014

The effect of this order will be to extend no waiting and limited waiting areas and to create a disable parking bay. Details are as follows:-
