NOTICE IS HEREBY GIVEN that Winchester City Council as agents for Hampshire County Council proposes to make an order on traffic management grounds to allow for routine maintenance works to be undertaken as follows:

ROADS TO BE CLOSED:

- 1. <u>A33 Basingstoke Road, Kings Worthy-Micheldever</u> between its junction with Lovedon Lane and a point 850 metres north of its junction with Rownest Wood Lane.
- 2. <u>Cott Street, Droxford</u> between its junction with the A32 Wickham Road and its junction with Droxford Road.
- 3. <u>Harwood Place, Kings Worthy</u> for its entire length.
- 4. <u>Hyde Abbey Road, Winchester</u> between its junction with Gordon Road and a point 200 metres north and west of that junction.
- 5. <u>Longwood Road/Main Road, Owslebury</u> between its junction with Belmore Lane and its junction with Whites Hill.
- 6. <u>Mountbatten Place, Kings Worthy</u> for its entire length.
- 7. Oak Road, Bishops Waltham between its junction with Willow Road and its junction with Rareridge Lane.
- 8. Rareridge Lane, Bishops Waltham between its junction with Oak Road and its junction with Hoe Road.

- 2. <u>Cott Street, Droxford</u> A32 Wickham Road, Droxford Road..
- 3. <u>Harwood Place, Kings Worthy</u> None.
- 4. <u>Hyde Abbey Road, Winchester</u> None.
- 5. Longwood Road/Main Road, Owslebury Whaddon Lane, B2177 Portsmouth Road, B3354 Main Road, Hazeley Road, Morestead Road..
- 6. <u>Mountbatten Place, Kings Worthy</u> None.
- 7. Oak Road, Bishops Waltham Willow Road, Hoe Road, Rareridge Lane.
- 8. <u>Rareridge Lane, Bishops Waltham</u> Hoe Road, Willow Road, Oak Road.

Alternative routes will be signposted at the time of closure. Individual road closures in the same area will be implemented consecutively and not simultaneously.

PERIOD OF CLOSURE:

From 1st April 2015 for a period of 12 months or until completion of the works.

Each road is only expected to be closed for the minimum period to facilitate the works. Exact durations will be notified on site.

With the exception of any emergency works, advance warning signs will be displayed approximately 2 weeks in advance of any road closure being enforced.

Reasonable facilities will be provided for access to adjacent premises while the work is being carried out.
