

<u>Commencement of Preparation of</u> <u>Winchester City Council – Local Plan 2036</u>

Notification under the Town and Country Planning (Local Planning) (England) Regulations 2012

Winchester City Council is about to commence preparation of its **Local Plan 2036** and wishes to hear from local communities, individuals and commercial businesses – in fact from anyone with an interest in this matter.

The purpose of the Local Plan is to provide a planning policy framework to direct growth and change to appropriate locations, in accordance with the National Planning Policy Framework requirement to achieve sustainable development. The Local Plan will also include a range of planning polices to inform the location, scale and appearance of developments. When adopted it will form part of the Development Plan for the area.

The Local Plan will cover the administrative area of Winchester City Council except for that part within the South Downs National Park, which has its own Local Plan.
