
BY THIS ORDER

- 1. The sections of the footpath over the land shown by a bold black line on the attached map and described in Part 1 of the Schedule to this Order shall be diverted as provided below.
- 2. There shall be created to the reasonable satisfaction of Winchester City Council alternative sections of footpath for use as replacements for the said footpath as provided in Part 2 of the Schedule and shown by bold black dashes on the attached map.
- 3. The diversion of the parts of the footpath shall have effect on the confirmation of this Order.
- 4. The applicant is hereby required to pay the cost of diverting and creating the sections of alternative highway referred to in Articles 1 and 2 above.
