### Winchester District Gypsy Traveller and Travelling Showpeople Development Plan Document

#### Adoption Statement

In accordance with the Planning and Compulsory Purchase Act 2004, Regulation 26 of the Town and Country Planning (Local Planning) (England) Regulations 2012, and Regulation 16 of the Environmental Assessment of Plans and Programmes Regulations 2004, notice is hereby given that Winchester City Council adopted the Winchester District Gypsy Traveller and Travelling Showpeople Development Plan Document, (the Traveller DPD), on 28 February 2019.

The Traveller DPD covers the administrative area of Winchester District excluding the area of the South Downs National Park Authority that lies within the District, and reflects policies within Local Plan Part 1 adopted in March 2013 and Local Plan Part 2 adopted in April 2017 which set out the identified need for travellers accommodation in the District to 2031.

The Traveller DPD includes the Main Modifications as recommended by the Inspector who carried out the independent examination of the Plan during September 2018. The Main Modifications are set out in the Inspector's report, and these were subject to a six week consultation period during October – November 2018.

Any person aggrieved by the Traveller DPD may make an application under Section 113 (3) of the Planning and Compulsory Purchase Act 2004 to the High Court on the grounds that the document is not within the appropriate power and/or a procedural requirement has not been complied with. An application may not be made without the leave of the High Court, and an application for leave must be made (Section 113 (3B)) before the end of the period of six weeks (11 April 2019) beginning with the day after the date of the adoption of this Traveller DPD.
