
#### BY THIS ORDER

- 1. The section of the footpath over the land shown by a bold black line on the attached map and described in Part 1 of the Schedule to this Order shall be diverted as provided below.
- 2. There shall be created to the reasonable satisfaction of Winchester City Council an alternative section of highway for use as a replacement for the said footpath as provided in Part 2 of the Schedule and shown by bold black dashes on the attached map.
- 3. The diversion of the part of the footpath shall have effect on the date on which Winchester City Council certify that the terms of Article 2 above have been complied with.
- 4. The applicant is hereby required to pay the cost of creating the section of alternative highway referred to in Article 2 above.
