Proposal: External wall mortar & render repairs 1. Rake out & re-point existing NHL and cement mortar joints on north, west and south-facing elevations. Re-pointing to be carried out in hot lime, flush finished, knocked back and brushed to match original.

2. To remove cementitious rendering from above leaded ground floor window on north-facing elevation and replace with fresh hot lime render. Existing NHL, cement mortar & cement rendering affecting 'breathability' causing dampness internally and masonry erosion.
