



NOTICE OF PROPOSED TRAFFIC REGULATION ORDER

The Hampshire (Various Roads Winchester) (Parking Places and Restriction of Waiting) (Controlled Zone) (Consolidation) Order 2010 (Variation No. 67) Order 2019

Winchester City Council as agents for Hampshire County Council gives notice that it proposes to make an Order under the Road Traffic Regulation Act 1984 and all other enabling powers. If the Order comes into force it will introduce the following changes:

- To remove the 'Pay and Display' requirement from three sections of designated parking place on Wales Street, Winchester and replace with the following:
